- Goal is to only use the \$10,000 that will be forgiven when the loan is paid back before December, 31, 2022.

- Ian Neuhaus questions the fiscal ability to pay back the loan. Sherry Thompson answers that she sees no issues being able to pay back the loan and anticipates that the loan will be paid back before the end of the fiscal year.

- **Motion to approve the application of the one time CEBA loan for up to \$40,000 of which only 75% of the total amount are required to be paid back before December 31, 2022.** (F. Klotz/ I. Neuhaus)- **carried**
